

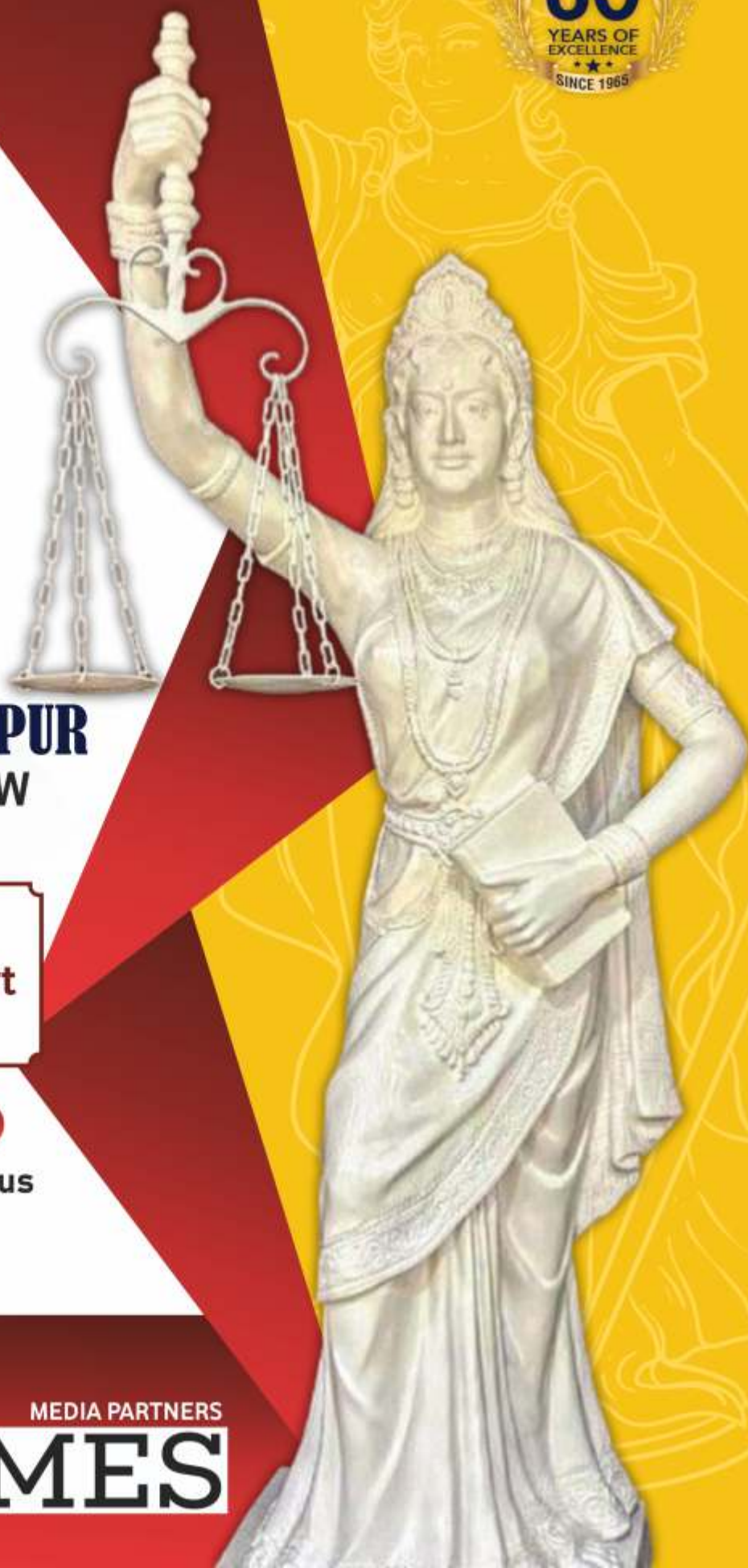

RULES & REGULATIONS

ELIGIBILITY

- ✓ *The competition is open for bonafide students 5 Year integrated and 3 Year LL.B. program from any recognized University/Institution approved by Bar Council of India.*
- ✓ *Each team shall consist of 3 members, (two 'Speakers' and one 'Researcher') or 2 members (two 'Speakers' and out of these two, one speaker has to be designated as a researcher as well). Maximum of 3 members and minimum of 2 members in a team are allowed.*
- ✓ *Only one team from any College/Law School/University is allowed to participate in the Competition.*
- ✓ *No additional member or team coach is allowed to accompany the team.*

SUBMISSION OF MEMORIALS

- *Participants have to send the soft copy of the Memorials, one from the Petitioner and one from the respondent side {both in Word (.docx/.doc) and PDF format}.*
- *Soft Copy of the memorials shall be sent to the given mail id: mootcourt@apexuniversity.co.in with the subject "Memorials for Team Code". The file names of the electronic copies of the Memorials must contain only the team code and the side being represented in the following format: e.g. (for Team Code TC08): TC08 (P) or TC08(R). The content of the memorials should not differ from the content of the soft copies submitted to the Organizers. The last date to send the soft copy of the memorial is October 5, 2025 by (23:59 hours IST).*
- *Last date for receiving of hard copies of each of the memorial for all participants will be October 15, 2025 by (23:59 hours IST).*
- *The teams must send Four Hard Copy (2 Petitioners & 2 Respondents) of their Memorials from each side to the following address:- Dean, Apex School of Law, Apex Girl's Hostel, Shipra Path, Mansarovar, Jaipur, and Rajasthan, India - 302020.*



- Identification mark of any type shall attract a severe penalty.
- The copies of the memorials must bear cover page in conformity with the following scheme:
 - Blue Colour - Appellant/ Petitioner
 - Red Colour – Respondent
- No amendment to the memorial will be permitted after submission. Teams are not permitted to raise arguments in the oral rounds that are not present in the memorial.
- Each memorial shall consist of the following headings in the same order as are mentioned below :-
 1. Cover Page
 2. Table of Contents
 3. List of Abbreviations
 4. Index of Authorities
 5. Statement of Jurisdiction
 6. Statement of Facts
 7. Issues Raised
 8. Summary of Arguments
 9. Arguments Advanced
 10. Prayer
- Each memorial shall consist of the following details on the cover page :
 1. Team code on the top right-hand corner of the cover page. Memorials without the team code will not be evaluated.
 2. Name and place of the forum.
 3. Name of the parties and their status.
 4. Memorial filed and the party that the team is appearing on behalf of the following content specification must be adhered to :
 1. Language - English
 2. Font and Size (Body) - Times New Roman, 12 pts



3. *Line Spacing (Body) - 1.5 lines*
 4. *Font and Size (Footnotes) - Times New Roman, 10 pts*
 5. *Line Spacing (Footnotes) - Single Line*
 6. *Page Margins - 1 inch on all sides*
 7. *Paper Specification - White A4 Sized Paper*
 8. *Body of the Memorial /Justified*
 9. *Citation style - Bluebook (20th Edn.)*
- *The memorial shall not be of more than fifty (50) pages and the Arguments advance shall not exceed more than thirty (30) pages.*
 - *The Memorial must be spiral bound ONLY. The Memorial must not contain any Annexure/Photographs/Sketches/ Exhibits/Affidavits etc.*

EVALUATION METHOD

Following schematics will be followed in the competition for the scoring of the teams.

Evaluation of oral arguments

Each speaker shall be marked a total of 100 marks by each Judge. The following will be the marking. criteria and the marks allotted to each category:

Researchers test

- ❖ *The Researcher's test will be conducted on day one of the competition.*
- ❖ *The duration of the test will be sixty minutes (60 minutes) only.*
- ❖ *The test shall consist of Objective / Subjective questions based on the principle of laws applicable and the case study*



- Memorials that do not comply with the above-mentioned specifications will be penalized as follows:

COMPETITION ROUNDS

There shall be two Preliminary Rounds, Quarter Finals, Semi-finals and Final Round spreading over a period of 3 days.

PRELIMINARY ROUNDS

- *There shall be two Preliminary rounds. In both the Rounds, the Participating teams shall argue for both the sides. The team which argue from one side in the first preliminary Round shall argue from another in the second Preliminary Round.*
- *The pairing of teams for the Preliminary Rounds shall be done by a draw of lots by the competition Organization Committee. No two teams shall argue against each other more than once in the Preliminary Rounds.*
- *Each Team will be given the Opposite Team's Memorials after the draw of lots. No team shall be provided any information regarding the identity of the opposite Teams or any other team participating in the Competition.*
- *The selection of the top 8 teams for the Quarter Final Rounds shall be based on total number of wins as well as the 'total scores' of teams after conclusion of both the Preliminary rounds. The selection shall be based on the following criteria :*
 - *First, the team with the highest total score after the two preliminary rounds shall be ranked higher. While deciding the Quarter finalists the wins secured by teams in both rounds will also be taken into consideration along with the scores, such that, the team with 2 wins in the preliminary rounds will be ranked higher than the team with a single win.*
 - *Second, for teams that have the same total round score and wins in the preliminary rounds, the team with the higher aggregate absolute speaker scores shall be ranked higher.*
 - *Lastly, if two teams have the same total round score, same wins and the same aggregate absolute speaker scores in the preliminary rounds, then the team with the higher memorial scores shall be ranked high.*



QUARTER FINALS

- *In the Quarter-Final, each Participating Team shall be assigned to argue for one side i.e., each team shall argue only once against the team determined by and for the side decided by a draw of lots.*
- *Each Team will be given the opposite Team's Memorials after the draw of lots.*
- *No team shall be provided any information regarding the identity of the opposite Teams or any other team participating in the Competition.*
- *It shall be a knockout round. The winner of each round shall move to the semi-finals. Four (4) teams shall move to semi-finals.*
- *In case of tie between teams, in Quarter Finals, the aggregate total of the marks of memorials (appellant and respondent) of the teams shall be counted. Team with highest marks shall move ahead.*

SEMI-FINALS/FINAL

- *The selection of 4 teams for the Semi-Final Round and of 2 teams for the Final Round shall be on a 'Knock-Out' basis.*
- *Four (4) teams shall compete in semi-finals. It shall be a knock out round. The winner of each semi-final round shall move to the Final round.*
- *The criteria of marking in this round will be aggregate total of the marks of both the speakers.*
- *In case of tie between teams, in semi-finals, the aggregate total of the marks of memorials (appellant and respondent) of the teams shall be counted. Team with the highest marks shall move ahead.*
- *There shall be one FINAL ROUND (1). The marking criteria in Final Round is the same as that of semi-finals.*

Important Note :

In all cases, decision of the Judges & organizers shall be final and abiding.

PART -I

FACTUAL MATRIX OF THE CASE

This matter concerns an appeal against the judgment delivered by the learned Sessions Judge of Bardmika who convicted Mr. Frederick a noted social worker and visiting professor at several academic institutions under the law relating to mutiny. Pursuant to this conviction, the appellant was sentenced to ten years of rigorous imprisonment.

The incident giving rise to the prosecution occurred on the 26th of January, 2025. On that day, the Mr. Frederick delivered a public address to an assembly convened for a meeting on social welfare initiatives of approximately two hundred individuals, the majority of whom were inhabitants of rural communities. The speech was characterized by inflammatory rhetoric, critical of the prevailing governmental structure and evocative of revolutionary sentiment. A summary of the contents of the speech, as recorded by witnesses and accepted by the trial court, is as follows:

Mr. Frederick alleged that, under the current regime, women described emotively as "mothers and sisters" had been reduced to a state of destitution so severe that many were forced to "sell their honour," a phrase understood to imply involvement in prostitution, simply to sustain themselves.

Mr. Frederick claimed that manual labourers had been brought to such levels of deprivation that they were left with no choice but to beg for alms.

Thousands of farmers and labourers, Mr. Frederick asserted, were suffering from starvation due to lack of food.

Mr. Frederick further alleged that the cost of living had been artificially inflated by the ruling authorities, citing specific examples such as the doubling of school fees and the quadrupling of railway fares measures Mr. Frederick claimed were deliberately implemented to crush the spirit of the agricultural classes and prevent their economic and social upliftment.

The speech included graphic accusations against the ruling Party, alleging widespread abduction of women, referencing mythological analogies, and further alleging that women were being compelled to become prostitutes to obtain food and clothing.

Mr. Frederick accused the State of imposing unjust taxes on the most fundamental human experiences birth and death indicating that the population was being subjected to fiscal exploitation at every stage of life.



Mr. Frederick suggested that Frenchlands cultivators and labourers were being metaphorically "bled dry" by the influence of foreign capitalists operating in collusion with domestic elites.

Mr. Frederick claimed that the working classes of Bardmica had now achieved a degree of organisation and unity. No longer, Mr. Frederick declared, would they submit to passive suffering or plead for mercy. Instead, they would now resort to active resistance, metaphorically "taking up cudgels" and physically encircling the government ministry to demand their rights, warning that failure to meet these demands would result in the downfall of the existing regime.

In a particularly incendiary portion of Mr. Frederick address, he suggested that if the nation were to be ruled by cultivators and labourers as Mr. Frederick argued it ought to be then every young man must be trained in the use of weapons, including swords, firearms, batons, and even incendiary tools such as spirit bottles. Mr. Frederick emphasised that the existing government would not yield power voluntarily and that, historically, no government had been dismantled without resort to violence. Consequently, Mr. Frederick advocated for the formation of agricultural and labour collectives which would organise into militarised groups or "armies."

Mr. Frederick then drew parallels with the governmental structure of communist country, stating that if Frenchlands desired a system

similar to that of communist country, they must establish a force of volunteers and train them in armed warfare. Mr. Frederick concluded by making inflammatory historical comparisons, asserting that despotic rulers of the past did not divide Frenchlands. Instead, Mr. Frederick alleged that the true architect of national disunity was minister of ruling government, whom Mr. Frederick labeled as a "great traitor" responsible for the present condition of the state.

The Mr. Frederick did not deny having delivered the speech in question but contested the precise wording attributed to him in the official record. Moreover, as part of Mr. Frederick defence, he raised a constitutional challenge against the very provision under which he was charged. He contended that law relating to mutiny had become void under the provisions of the Constitution of Frenchlands, which renders pre-constitutional laws void to the extent that they are inconsistent with the fundamental rights enshrined in the Constitution, particularly the right to freedom of speech and expression.

The learned Court below, however, held that the speech in question had indeed been made substantially as alleged. It is further held that law relating to mutiny represented a "reasonable restriction" upon the fundamental right to freedom of speech, as permitted by the Constitution in the interests of maintaining public order and protecting the sovereignty and integrity of the State. As such, the law relating to mutiny remained constitutionally valid, and



the Mr. Frederick was accordingly convicted and sentenced.

In a separate but related matter, the ruling government has filed Criminal Appeal, challenging an order of acquittal issued by an Additional Sessions Judge. The respondent in that case, Mr. Henry, had been charged of criminalises the promotion of enmity between different groups on grounds such as religion, race, place of birth, residence, language, etc., and acts prejudicial to national integration.

In a corresponding appeal, Mr. Henry has contested his conviction asserting, inter alia, that the provision invoke in his case has lost its validity due to provision referred in the Constitution of Frenchlands. Mr. Henry

constitutional grounds and seeking an acquittal.

Additionally, the State has filed Criminal Revision, seeking enhancement of the sentence imposed upon Mr. Henry for the offence under the law relating to mutiny. The prosecution contends that the sentence awarded is manifestly inadequate, considering the gravity of the offence.

Finally, in Criminal Miscellaneous Petition, one Mr. Joe, who has been arrested under the law relating to the mutiny, has approached the court seeking a writ of habeas corpus for his principal ground of challenge is the alleged unconstitutionality of law relating to the mutiny, which he contends has been nullified by





PART -II

Parties are free to frame two questions of law relating to mutiny that highlight the provisions of criminal, constitutional, and international law.

- *State will be represented by the Learned Advocate General.*
- *In view of the seriousness of the matter, this Court is inclined to appoint the Learned Solicitor General of Bardmica as amicus curiae to submit a brief submission (including criminal, constitutional, and international aspects) on the law relating to mutiny, outlining its pros and cons, to assist this Hon'ble Court before the parties begin submitting their arguments.*
- *The central legal questions arising in the present matter is whether the statutory provisions relating to mutiny have become ultra vires in light of the fundamental rights enshrined in the Constitution of Frenchlands. Whether the offence of mutiny can be construed as an affront to the tripartite structure of the State comprising the Executive, Legislature, and Judiciary or whether its legal implications are limited to an offence against the Executive arm of the Government alone? In view of the constitutional significance and far-reaching implications of the issue, this matter shall be placed before a Constitutional Bench comprising five Hon'ble Judges for authoritative adjudication. All parties both the State and private litigants are hereby advised to frame their submissions with a forward-looking perspective, taking into account the evolving constitutional landscape, the current*

socio-political environment, and the potential long-term consequences of any ruling on this subject. The Court recognizes that the nation is presently undergoing multiple institutional and legal developments, which underscore the need for a holistic and contemporary approach to the arguments presented. This Court, as the guardian of the Constitution and the temple of justice, bears the solemn responsibility of ensuring that the principles of equity, justice, and constitutional balance are preserved. Accordingly, the adjudication of this matter shall strive to uphold both the sanctity of individual liberty and the legitimate interests of the State, thereby maintaining the delicate equilibrium between personal freedoms and governmental authority.

- *Parties are requested to argue on the side of the Appellant as well as on the side of the Respondents before the "Hon'ble Court of Republic of Frenchlands" pertaining to the above case and further elucidate the arguments with appropriate case laws and inputs.*
- *The laws of Republic of Frenchlands are pari material with laws of India. The Republic of Frenchlands considers the leading common law precedents as being highly persuasive. Hence, all the relevant ancient, modern, texts of Indian law may be referred for arguing the case.*
- *This Moot Problem has been formulated solely for the purpose of this competition for furthering the academic exercise only.*
